Awards: Ribbons will be self-serve. Ribbons are awarded for Qualifying score, Best of Breed, High in Class and New titles.

Notice to Exhibitors:

All NASDA profits will be donated to Border Terrier Health.

Bitches in season will run at the end of their class and must wear appropriate panties.

Please make a copy of your entries so you know what you've entered before and after you arrive at the tests.

No refunds will be made for cancellations after 2/28/24 (or after the pre-entry closing date) or entries that are absent, disqualified, excused or barred from competition by decision of the Trial Committee.

Exhibitors are responsible for complete, accurate and **LEGIBLE** information on their entry forms. Be especially careful that your email address is clear.

Exhibitors are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children, and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.

All dogs must be on leash **at all times** except when competing.

Exhibitors are responsible for being in the staging area when it is their turn to run.

Please be courteous and pick up after your dog.

All entries must be accompanied by entry fees to be valid. Returned checks do not constitute a valid entry. There will be a \$40 fee for any returned check. Please make checks payable to Fortune Farms LLC.
